


## Lord Pond Plaza Mural Design Competition

The Town of Athol, in conjunction with the North Quabbin Community Coalition, is inviting artists of all ages to participate in a mural design competition to celebrate the greening of Lord Pond Plaza!

**BACKGROUND**—The Town of Athol has begun assessing the feasibility of redeveloping Lord Pond Plaza into urban green space through a grant from the Massachusetts Municipal Vulnerability Preparedness (MVP) Program. This assessment will identify opportunities to incorporate nature-based solutions and green infrastructure into the Lord Pond Plaza parking lot area, such as stream daylighting, shade trees for cooling, green space for stormwater and flooding mitigation, and open space improvements. The selected mural design will help celebrate and broadcast this effort.


**MURAL DESIGN COMPETITION**—The theme for the mural project is "Greening Lord Pond Plaza." The selected design will be painted on a 4' x 8' plywood sheet for outdoor display. The design competition is open to any individual residing in Athol who can create art appropriate to the theme and setting. Students in grades 7-12 are especially encouraged to submit mural designs. # CHCFC Health Connector Navigator Available

As you may or may not know, Open Enrollment for health insurance through the Health Connector has been extended until May 23, 2021. The Community Health Center of Franklin County (CHCFC) has a Health Connector Navigator that can assist you with the application and answer any questions. Their Navigator, Wendy, can also assist you with applying for MassHealth which has no open enrollment period, so you can apply at any time. You can also apply for health coverage at any time if you have a qualifying event such as losing insurance at a job, a change in income, marriage, birth, or are new to the area. Wendy does not make appointments in the office, but will work with you over the phone (413-325-8500 x146) at your convenience. You can start your own application for MassHealth or the Health Connector at <a href="https://www.mahealthconnector.org">https://www.mahealthconnector.org</a>. You can also upload your own documents and make payments there. The coverage that you are available for is dependent on your income and the size of your tax household. ## Housing Mediation Program

Collaborative Resolutions Group

Collaborative Resolutions Group (CRG, formerly The Mediation & Group
Training Collaborative) is part of the state's Eviction Diversion
Initiative (EDI), and is the state-designated EDI community mediation center for Franklin County
(also serving Hampshire and Hampden counties). CRG's Housing Mediation Program helps landlords and tenants work out issues before they get worse and lead to eviction and other serious crises.
Circumstances in which community mediation may be a helpful tool:

- People aren't far apart, or are collaborative, and just need a little help to reach an agreement and work out the details
- Issues beyond non-payment (such as property condition or landlord/tenant behaviors)
- Miscommunication (or lack of communication) is a primary barrier
- High conflict, tough communication, seemingly impossible case (complex, multiple issues, personal relationships at stake)
- Tenant isn't eligible for subsidies but both are willing to explore other options to resolve the issue
- "Softer landing" may be possible with a mediated agreement

With support from the Massachusetts Eviction Diversion Initiative and the Attorney General's Face to Face Mediation Program, housing-related issues can be mediated free, confidentially, and at times that work for the people involved either online or by phone. # Warwick to Host 2nd Virtual MVP Community Resilience Building Workshop

The Town of Warwick invites town officials, residents, businesses, and other interested community members to attend the second of two virtual workshops on March 8 from 6:00 to 8:00 pm to discuss impacts of climate change on the town and to develop strategic actions to build resilience to those impacts. The workshops are part of a combined MVP Community Resilience Building and Hazard Mitigation Regional Plan with the Town of Northfield, in partnership with the Franklin Regional Council of Governments (FRCOG) Planning Department.

The March 8 workshop will build upon feedback collected at the first workshop on February 17 and over the past year about climate change threats and challenges facing the town. How can Warwick address impacts from stronger storms, longer power outages, isolation from downed communications and blocked roads, threats to forests, water quality, and public health? Participants will help prioritize these and other challenges, and identify community strengths and actions to address the challenges moving forward.
